The following are our terms and policies for payment of 4 the Kids Toy Store products. Any changes to these terms or policies must be approved in writing by 4 the Kids Toy Store.

**To Place an Order:** Email to your purchase order to [orders@4thekidstoystore.com](mailto:orders@4thekidstoystore.com) or fax to: 801-393-0437

**Verification of Order:** All orders will be verified via email or fax within 2 business days.

**Shipping:** Products will be shipped to your company or to your facility via UPS or common carrier of our choice. Shipping charges are not reflected in the product pricing and are added to your invoice. Shipping of products normally occurs within 7-10 business days of receipt of order. In the event that shipment is not within this time period, we will notify you. Any order to a *residential address* must be marked on the purchase order as such. Any fees incurred by us for an order not properly marked as residential will be passed on to you.

**Terms:** You will be invoiced via fax or email at the time of shipment of each order. Terms of each invoice are Net 30 with approved credit.

**Pricing:** Net prices for each product are as listed on the current website [www.4theKidsToyStore.com](http://www.4theKidsToyStore.com). Pricing is subject to change without notice.

**Satisfaction:** 4 the Kids Toy Store takes the satisfaction of all our customers very seriously. If you are not satisfied with your product from us you may return it within 30 days for a refund excluding shipping charges. The item must be returned in the same condition as it was received. In the event an item arrives damaged, 4 the Kids Toy Store must be notified within 10 days of receipt of item. We will then replace the item or parts as necessary at no charge.

**Warranty:** All products are covered by our full one-year warranty. During this period we will repair or replace, at our discretion, any product that is defective in materials or workmanship. Our warranty does not cover damage caused by abuse.
